Eligibility Criteria:

1. Applicant currently studying for a professional course in a professional college

Or

Applicant finishing Plus2 in April 2023 and wish to enrol in professional courses

- 2. Applicant should have obtained above 70% marks in the previous year board examination.
- 3. Scholarship will be provided only to those wish to join or studying for full time professional courses described above in a reputed College affiliated to recognised Universities in India.
- 4. Candidates who wish to join Correspondence or any part time courses are not eligible to apply.
- 5. Scholarship will be awarded to those students who have passed their qualifying examinations (SSLC, +1 &+2) in the 1st attempt.
- 6. Students eligible for public study funding will not be considered.
- 7. Applicants who have got admission for any professional courses through entrance exams, they are exempted from minimum mark requirements for SSLC, +1 and +2.
- 8. Scholarship shall be discontinued after completion of the course.
- 9. Share and Care will not pay for break year/semester fees
- 10. Applicant's entire family should have BPL card.
- 11. All applications should be submitted to MICA Share And Care through a MICA member.

- All Applications will be scrutinized thoroughly by MICA Committee members for their Academic results, financial, health and dependency condition of the applicant's family, extracurricular activities and conduct of the applicant

- Application Accepted/Rejected status will be intimated by E-mail/Phone provided by the applicant.
- The Scholarship amount will be debited yearly to the College directly by the MICA Share and Care
- The Decision of the committee is final.

Selection Process steps

- 1) Applicant forward documents to the MICA Member (Referee Applicant)
- 2) Referee applicant fill in application form on behalf of Applicant, fill in Point allocation section and sign the declaration section.
- 3) Referee Applicant submit application to MICA Share And Care with all documents from applicant through the Email info@micashareandcare.ie
- 4) MICA Share and care dedicated team evaluate each form and assign a unique application number which then communicated to Referee applicant.
- 5) MICA Share and care dedicated team short list the applications.
- 6) If the application needs +2 marks update, hold the applications until the due date for final selection
- 7) Select the candidate and announce that the candidate is selected (actions as per GDPR)
- 8) Inform the selected candidate and make necessary arrangements as required with candidate
- 9) Contact college and make necessary arrangements with them for payment
- 10)MICA Share and Care releases payments to college in accordance with requirements

Eligible candidates can send the application along with following documents via email to the referee in Ireland. Referee can then complete the marking sheet and forward it to info@micashareandcare.ie.

Documents required:

Mandatory:

- 1. A handwritten application from the student with contact number and Email address
- 2. Annual family income certificate from the Village office
- 3. Recent Conduct Certificate from the school (Max 3 months)
- 4. Passport size photo (affix to the application)
- 5. SSLC/10th,11th, 12th marks sheet and certificates
- 6. Address proof and Identity proof pertaining to the applicant. (Adhar card, Ration card etc.)
- 7. BPL Card
- 8. Copy of Student Bank Account passbook showing student photo and account number
- 9. 2 Reference letters
- 10. Accommodation (Letter from concerned Govt office or authorised dignitaries from the Local community confirming the status)

Optional:

- 11. Bank details with IFSC code (If applicable)
- 12. Certificate of extracurricular activities of District/ State level (if applicable)
- 13. Parent's Status -Sick (Medical certificate of parents) if applicable
- 14. Parent's Status- diseased (Letter from concerned Govt office or authorised dignitaries from the Local community confirming the status) if applicable
- 15. Involvement in extracurricular activities (Copy of certificate should be provided) if applicable
- 16. Handicapped (Certificates confirming the nature from the proper authority) Those who can't get an admission to the institution with the current status won't qualify, i.e., those whose who can't be able to do the course If applicable
- 17. Non-life-threatening diseases (Certificate confirming the state of the candidate and certify that the candidate can be able to do the course with no risk involved). Those who can't be able to do the course with the current state of health won't qualify, if applicable
